Your application for a solid waste license amendment to modify Department of Environmental Protection (Department) license #S-020700-WD-BC-A Condition 10, as revised in Board of Environmental Protection Order #S-020700-WD-BG-Z, was received by the Department on November 27, 2017 and was accepted for processing on December 15, 2017. The application request is for the removal of the municipal solid waste acceptance date of March 31, 2018 applicable to the existing JRL landfill. This application had been assigned the following license number: #S-020700-WD-BL-A.

Public comments on the application may be submitted to the Department during the Department's processing of the application. Requests for the Board of Environmental Protection to assume jurisdiction or for a public hearing on the application must be received by the Department, in writing, by the close of business on January 4, 2018.

At this time, the Department will begin its substantive review of the above noted application. Acceptance of the application as complete for processing is not a determination of the sufficiency of the information and does not preclude the Department from requesting additional information.

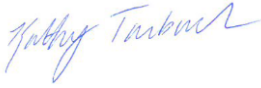
