
- The Azure Platform upgrade team has had some much-needed success and is still working to get things squared away.
- The first release of the Western Mountains LiDAR has arrived.
- The NOAA Bathymetry Data is due to be released in early April.
- The Vexcel Imaging is live for State users. As of this writing the local copy has not yet been delivered to the 911 team, and work is in progress to get that done.
- The Vexcel Joinder Agreement is still in progress, Vexcel's legal department is "backed up". This must be completed for us to release the full ESRI installation package to Towns and other Non-State governments. We have executed one agreement with the 911 contractor.
- Claire Lawrence, our new Intern, will be starting as soon as her equipment arrives. She'll start by doing an inventory on the metadata and prepping for outreach work.
- Josh, our new Analyst, will be starting by the end of the month.

Content Update – DEM and Land Cover

- DEM sewing is about half-way through. Results are looking good.
 - From the testing we have done we are assuming the RMSE for the vertical accuracy is 23"
 - The aggregate distances we are seeing after the sewing are in the range of +/- 10".
 - Current issues with the project are coming down to how big an area can be processed at one time.
- Land Cover is dependent on getting the DEM work done. Processing will begin after the DEMs are sewn.
- Other projects under discussion are a "Height Layer", tree typing, and stand analysis.
- An agreement will need to be signed with UMaine to deliver them the Vexcel imagery, like the Cities and Towns.

- We have an opportunity to expand the use of GIS in these areas with outreach and support.
